#### **Agency for Persons with Disabilities**

APD works with local organizations and private providers to support people who have developmental disabilities and their families in living, learning, and working in their communities. APD identifies the service needs of people with developmental disabilities, and those individuals may receive social, medical, behavioral, residential, and/or therapeutic services.

The agency serves more than 50,000 Floridians with the following disabilities:

- People severely impaired by autism
- Cerebral palsy
- Spina bifida
- Intellectual disabilities
- Down syndrome
- Prader-Willi syndrome
- Phelan-McDermid syndrome
- Children age 3-5 who are at a high risk of a developmental disability

## Center for Autism & Related Disabilities (CARD)

Florida is home to many individuals with autism and related disabilities. In response to the needs of these people and their families, seven regional, nonresidential resource centers have been established.

The Centers serve both children and adults of all levels of intellectual functioning who have autism spectrum disorders, dual sensory impairments, or sensory impairments with other disabling conditions recognized by Florida's Agency for Persons with Disabilities (APD). A constituency board comprised of family members representing persons with autism and related disabilities meets quarterly with Center staff to provide guidance on policies, priorities and activities.

#### **FDLRS and FIN**

The Florida Inclusion Network (FIN) collaborates with all districts and schools to provide customized services and supports ensuring all students with disabilities have the same educational, social, and future opportunities as their peers.

- 1. Data-driven, student-focused planning and problem-solving across districts and schools.
- 2. Data-driven professional development and technical assistance to increase knowledge and skills of district and school personnel.
- 3. Coaching and resources for district and school personnel to sustain inclusive best practices.
- 4. Sharing information to build collaborative relationships between families, schools, and districts.
