Student Parking Permit Application and Consent to Search and Waiver of Liability

The undersigned student hereby applies to the School District of Osceola County (SDOC) for a Student Parking Permit Decal. In making this application, I understand, acknowledge and agree to the following conditions as a prerequisite to, and in consideration for, the issuance of a Student Parking Permit Decal which authorizes me to drive and park on a SDOC school campus.

- 1. I agree that it is a privilege, not a right, to have a Student Parking Permit Decal and to drive or park on a SDOC school campus. I agree that if I fail to comply with SDOC policy, the policies of my school, and/or the conditions contained in this application, SDOC may immediately revoke my Student Parking Permit Decal and driving/parking privilege.
- 2. I agree that the Student Parking Permit Decal that I am issued and the parking place I use shall remain the property of SDOC.
- 3. I hereby waive any expectation of privacy in any vehicle and its contents that I drive or park on a SDOC school campus.
- 4. I hereby give consent and authorize the SDOC, its employees and its agents located within the State of Florida, to open and search any vehicle and its contents that I drive or park on a SDOC school campus at any time, without prior notice or additional consent and without my knowledge or presence.
- 5. I understand that if I refuse to cooperate with the search of a vehicle, pursuant to this agreement, SDOC may have the vehicle immediately towed or removed from the school campus at the owner's expense.
- 6. I agree that I am responsible for the contents of any vehicle I drive or park on a SDOC school campus.
- 7. I agree that the SDOC, its employees and its agents located in the State of Florida, shall not be responsible and are released from liability for any theft, loss, or damage to my property or vehicle while on a SDOC school campus. I also agree that the SDOC, its employees and its agents located in the State of Florida are hereby released and held harmless from all liability, claims, or damages, connected in any way with the search of a vehicle I drive or park on a SDOC school campus, or the removal of a vehicle as provided above.

General Information

- All automobiles parked on school grounds must be registered with the school and must display the current Parking Permit Decal.
- Parking Permit Decals will be sold on a first come first serve basis.
- Parking is strictly limited to the assigned student parking area(s) only.
- Automobiles are to be parked front end first.
- All students must be licensed and covered by appropriate insurance. The school is not responsible for the automobile or its contents.
- No loitering is allowed in the parking lot or visitation of the same without permission.
- There is to be no speeding over five (5) miles per hour or any other form of reckless driving on school grounds.
- Parking regulations are strictly enforced. It is a privilege, not a right, to drive or park on school grounds. Suspension of driving privileges and/or disciplinary action according to the Student Code of Conduct may occur when violations of these regulations occur.
- · Vehicle must be registered in the State of Florida.
- Off Campus actions may result in Parking Pass being revoked.
- Copy of Registration, Insurance Card and Driver License must be provided.
- Park at your own risk. The school is not responsible for damaged, lost, or stolen property. Since SCHS is private property, SCPD dose not investigate accidents.
- Parking Fees: Reserved Lot (Full time SCHS) \$40, General Lot (DE/OJT) \$40

- A Parking Permit Decal is leased to the student and is the property of the school. It must be returned to the school upon student withdrawal. Parking Permit Decals may not be sold, traded, duplicated, loaned to other vehicles, exchanged, or used in any manner other than to identify the individual student who has properly complied with school regulations in order to exercise the privilege of driving and parking on a school campus.
- Lost Parking Permit Decals must be replaced at the original price.
- Vehicles will give the right of way to school buses at all times. Bus loading areas will be free from traffic before and after school.
- Trash containers, driveways and/or other loading and unloading zones will not be blocked. Vehicles which are parked in these areas are subject to towing at owner's expense.
- Fees for a Parking Permit Decal are non-refundable.
