Horizon Middle School will host several activities after school that will encourage and support parents at home. All stakeholders will be able to participate in these school-wide activities. At the beginning of the school year, Open House allows parents to visit the school and view its resources. Welcome Back Packets are provided to all students that includes a Title I booklet, District LEA Parent & Family Engagement Plan Summary and School Parent & Family Engagement Plan Summary. Every new student that is enrolled throughout the year is provided a copy of the packet upon registration. In addition, a Title I menu to access links to Title I is available through the school's website.

Curriculum being used at the school is addressed at the school SAC and PTO meetings. At our Title I Annual Meeting, a PowerPoint is shared with the parents and families regarding information on the standards the child is expected to achieve, what the child is learning, how the children are being evaluated, and how to get in touch with the teacher.

Any parent is able to request a parent/teacher conference in person or telephone. Parents may contact teachers via email. All teacher email addresses are available on our school website and through FOCUS.

An electronic version of our Title I survey is provided to parents to get feedback on curriculum, testing, barriers, etc. Data is collected and results from the surveys are provided in the Spring and shared with parents. All parents are invited to discuss the results and ways to improve our school for the upcoming year.

Our school has a dial out system called School Messenger that is used to contact parents in regards to events happening at the school, as well as emergencies. Automated messages are provided in English and Spanish. Osceola County School District has a virtual backpack website that parents can visit to see the various community businesses that are involved with the district schools and areas.

Parents and stakeholders will be notified of upcoming event by social media (Remind, Twitter, Instagram, Facebook), using the school's marquee, sending home flyers with students, and updating the school's website as needed. Information will be sent home on flyers in both English and Spanish. A dial out in both English and Spanish will also be used.

Barriers

A description of the barriers that hindered participation by parents during the previous school year from the school end of year survey?

Community outreach was previously a barrier to building relationships with families. Our school struggled to get timely information out to families, which led to a lack of participation in our Title I and after-school events. In the last two years, we have increased the number of methods for outreach, increasing our social media presence and keeping Focus and our school's website calendar up to date. Our social media followers have more than doubled and has been the best way to communicate information to parents. For events, we plan several days in advance, to push out intentionally timed posts to inform and remind families about events. We continue to send flyers home in multiple languages and often attach it to something parents typically interact with like printed progress reports, assessment reports, or printed report cards. We continue to use dial-outs and text messages in English and Spanish through Remind or Blackboard and include event information on our marquee.

The committed involvement of our SAC/PTSO members in our school, and their outreach to bring more families into the school is so highly valued and appreciated.
