# EACH EXPANDED LEARNING PROGRAM:

POPULATION: ✓ SERVES 50 STUDENTS IDENTIFIED FOR ADDITIONAL ACADEMIC SUPPORT AND ENRICHMENT.

## SCHEDULE:

✓ EVERY MONDAY THROUGH FRIDAY ✓ FROM 8:20 AM TO 3:20 PM, AND IT IS COMPRISED

✓ OF 6 DAILY SESSIONS OF 45 MINUTES

 $\checkmark$  PLUS 1 HOUR PER DAY FOR STUDENTS WITH TRAUMA.

SUPPORT OR RELATED SERVICES ARE PROVIDED IN SMALL GROUPS IN A SEPARATE SETTING WITHIN THE SCHOOL AND ARE COORDINATED WITH THE REGULAR SCHOOL DAY TEACHERS FOR LEARNING CONTINUITY.

### EACH EXPANDED LEARNING PROGRAM SERVES:

STUDENTS IN GRADES K-5 WILL HAVE PRIORITY FOR SERVICES IF THEY MEET THE FOLLOWING CRITERIA:

- (1) CONSISTENTLY BELOW ACADEMIC PROFICIENCY IN ELA, MATH OR SCIENCE
- (2) MULTIPLE RETENTIONS IN 1 OR MORE GRADES
- (3) HIGH NUMBER OF DISRUPTIVE BEHAVIOR AS EVIDENCED BY DISCIPLINE REFERRALS
- (4) STUDENTS WITH DISABILITIES WITH MENTAL, SOCIAL AND/OR PHYSICAL TRAUMA
- (5) STUDENTS WITH MENTAL, SOCIAL AND/OR PHYSICAL TRAUMA






## OUR STRATEGIES: UNLIKE THE AFTERSCHOOL PROGRAM, THE ELP TAKES PLACE DURING THE REGULAR SCHOOL DAY THEREFORE ONCE STUDENTS ARE CAREFULLY SELECTED BASED ON THE PROGRAM CRITERIA THE ADULT FAMILY MEMBER(AMF) AND REGULAR DAY CLASSROOM TEACHERS WILL BE INFORMED IN WRITING OF THE EXPANDED LEARNING PROGRAM'S GOALS, OBJECTIVES, PARTICIPATION GUIDELINES AND ACTIVITIES TO BE EMPLOYED TO IMPROVE THE STUDENT'S ACADEMIC, BEHAVIORAL AND/OR EMOTIONAL ADVANCEMENT. AFM WILL BE ASKED TO SIGN A CONSENT FOR PARTICIPATION.

ADDITIONAL STRATEGIES: Homogeneous, by grade level, groups will be created, and services/sessions will be conducted daily in a 45-minute block via a "pull-out program". The ISC and/or the intervention via a "pull-out program". The ISC and/or the intervention teacher will personally pick up each participating student as mell as returning them to the class at the end of each session. Well as returning them to the class at the end of each session. Well as for students to exit the program when they have made the goal is for students to do well with the classroom support. Sufficient progress to do well with the classroom support. Afm and regular classroom teacher for continuous monitoring. **CODE OF CONDUCT IN THE EXPANDED LEARNING PROGRAM:** THE SDOC CODE OF STUDENT CONDUCT IS PUBLISHED EACH YEAR TO CLEARLY COMMUNICATE THE BEHAVIORAL EXPECTATIONS FOR STUDENTS AT ALL GRADE LEVELS AND TO SUMMARIZE THE POLICIES OF THE SCHOOL DISTRICT RELATIVE TO MANAGEMENT OF STUDENT CONDUCT. IT OUTLINES THE RESPONSIBILITIES AND RIGHTS OF ALL STUDENTS, DEFINES THE DISTRICT RULES OF CONDUCT AND THE BEHAVIORAL EXPECTATIONS FOR STUDENTS, IDENTIFIES THE CONSEQUENCES FOR VIOLATIONS OF THE RULES OF CONDUCT, AND CLARIFIES THE PROCEDURES FOR PROCESSING DISCIPLINARY INFRACTIONS.
