



3 STEPS FOR COMPLETING OSCEOLA PROSPER REQUIREMENTS

STEP ONE: APPLY TO VALENCIA OR OTECH AND COMPLETE FLORIDA RESIDENCY



Apply to Valencia through valenciacollege.edu. or oTECH through osceolaschools.net/otech. Once the application is processed, you will need to complete the Florida residency documents with your Valencia or oTECH advisor.

STEP TWO: COMPLETE THE FAFSA!



Complete the 2024-2025 FAFSA on studentaid.gov. The student and a parent/guardian will each need to create an FSA ID and then use the 2022 Federal Tax Return to complete the application. There are separate portions for the student and the parent/guardian to complete.

STEP THREE: COMPLETE THE SENIOR SURVEY



In order for us to know where to send transcripts, all seniors must fill out the End of Year Senior Survey indicating what they are doing after graduation. Be sure you put Valencia or oTECH!

Planning on Using Osceola Prosper?

To qualify for Osceola Prosper, all students must complete the FAFSA and complete Residency forms. All residency documents must be the parent/guardian's information to prove residency in Florida. Without a completed 2024-2025 FAFSA and completed Residency forms, students will have to pay out-of-state tuition (which is \$10,000).

HOW TO COMPLETE THE FORMS:

Residency forms will be completed at the orientation with your oTECH advisor.

Valencia Residency Request Form

For help completing Valencia residency forms, please come into the Career Center during an elective period any Monday or Tuesday with pictures of the parent/guardian's documents. Directions to find form on Atlas are below:

WHAT YOU WILL NEED:

Please bring pictures of your parent/guardian's Florida driver's license or ID card; in addition bring a picture of the parent/guardian's Florida Voter Registration Card **OR** Florida Vehicle Registration, as well as most recent immigration documents for you and your parent/guardian if not born in the US.

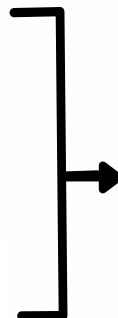

INDEPENDENT INFORMATION

- The Florida license plate must remain with the registrant upon sale of vehicle.
- The registration must be delivered to a Tax Collector or Tag Agent for transfer to a replacement vehicle.
- Your registration must be updated to your new address within 30 days of moving.
- Registration renewals are the responsibility of the registrant and shall occur during the 30-day period prior to the expiration date shown on this registration. Renewal notices are provided as a courtesy and are not required for renewal purposes.
- I understand that my driver license and registration will be suspended immediately if the insurer denies the insurance information submitted for this registration.
