



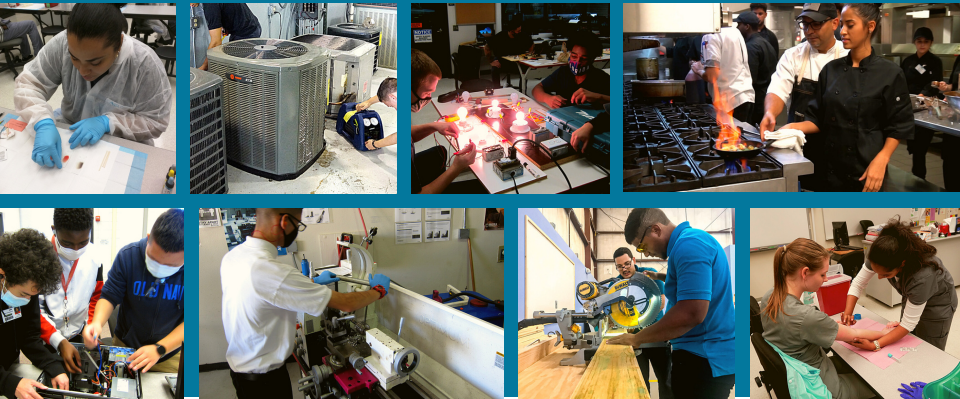

Application Submission Instructions:

- **Complete all fields on the application.**
- **Participation in an Orientation will be required as the final step of the admissions process. An Orientation date will be assigned during the month of April.**
- **You will receive confirmation of you application submission via email.**

Dual Enrollment acceptances are based on the following criteria:

- **Student must be a junior or senior**
- **Minimum 2.0 unweighted GPA**
- **Student meets graduation requirements at the time of application**
- **Student demonstrates mastery on FSA exam during 10th grade OR has produced an appropriate concordant score on the SAT or ACT exam OR has an official FSA waiver from their high school**
- **Student must have minimal attendance issues (i.e. tardiness, absences, skipping class)**
- **No level 3 referrals or higher within previous 6 months**
- **History of satisfactory academic progress**
- **Adult Basic Skills test is required within the first 6 weeks of start date (to be taken at oTECH)**
