

Planning on Using Osceola Prosper?

To qualify for Osceola Prosper, all students must complete the FAFSA and complete Residency forms. All residency documents must be the parent/guardian's information to prove residency in Florida. Without a completed 2024-2025 FAFSA and completed Residency forms, students will have to pay out-of-state tuition (which is \$10,000). Please complete these ASAP!
