**NOTE:** Opening date of the bid has been changed to Friday, August 25, 2006 at 11:30 AM.

**QUESTION:** Both of these bids have the work hours listed as 5:00pm to 10:00pm. Can these hours be changed at all? Would a shift from 11:00pm – 4:00am be allowed?

**ANSWER:** The hours listed on the bid are when the cleaning is to be done. Only for certain occasions can it be changed, and then only for an hour or two in either direction. Hours from 11:00pm – 4:00am will not be allowed.

**QUESTION:** On the current bidder for Narcoossee Community School (07-018), the monthly price is \$12,606.53 and the portable price is \$161.70. Does that mean it's \$161.70 x 20 portables + The \$12,606.53 for each month?

**ANSWER:** Almost, currently there are only 19 portables on campus, the 20<sup>th</sup> won't be put in place for about another month. However, that is what the will pay once the new portable is in place and used. When the bid was originally done, there weren't <u>any</u> portables on campus, since they have been added over the last 5 years they are paying the per portable price. However, with the new bid, they are to be included in your monthly cost.

**QUESTION:** Can we have a copy of the sign in sheet?

**QUESTION:** What is the square footage of the campus?

**ANSWER:** I called our facilities department and the have informed me the for Narcoossee Community School, the square footage is 213,734 nsf, which includes the portables, walk-ways and mechanical rooms. Per the bid, we give as close as possible the correct square footage, but may not be exact.

**QUESTION:** What is the comparison of VCT/Tile to carpet?

**ANSWER:** Unfortunately, no where on any paperwork is this broken down. Therefore, I am estimating that it is 90% VCT/Tile and 10% carpet.
