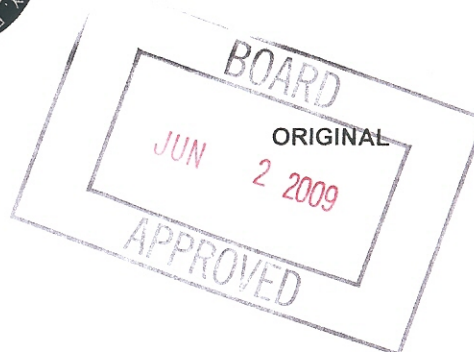


Dear Mr. Stelley:




