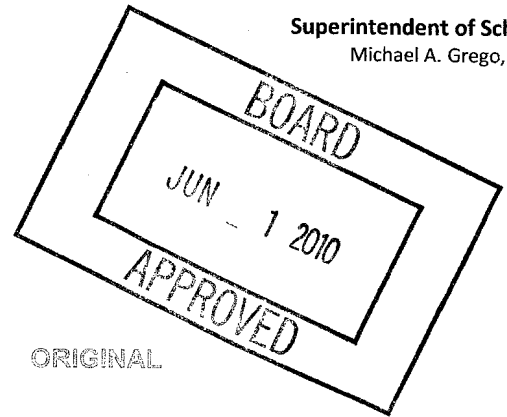

Dear Mrs. Malloway-Bralich:

Our current contract with your firm expires on September 19, 2010. Pending School Board approval, we would like to renew this contract for an additional one (1) year period. The bid's terms and conditions allow for two (2) one (1) year renewals of the contract under the same terms and conditions if agreeable to both parties. The second one year renewal period would begin on September 20, 2010 and expire on September 19, 2011.

During the first renewal period the District exercised its right to add or reduce square footage maintained as expressed in the solicitation document on page 25, paragraph 65. Additional/Reduction in square footage maintained "The District shall have the right to add or reduce square footage to be serviced under this contract". At this renewal, the District will be exercising its right to add or reduce square footage maintained by removing Narcoossee Elementary from the Scope of Services under this contract. Staff has decided to switch Narcoossee Elementary to in-house Custodial Services. This letter shall serve as written notice that August 31, 2010 shall be the last day for services to be rendered for Narcoossee Elementary under this contract. The pricing used for Narcoossee Middle remains as below and is in accordance with the original pricing submitted with the above mentioned bid. The calculations are as follows:

Narcoossee Middle School (Existing Building): 208,174 sq. ft. Original cost \$15,646.00 minus (-) 19 portables at \$160 each equals (=) \$12,606.00 per month.






