To be opened, **November 28, 2007** at 2:00 p.m., in the School District of Osceola County, Purchasing Office, 817 Bill Beck Boulevard, Kissimmee, Florida 34744.

During the Pre-Bid Walk-Thru it was obvious that the current service within the four (4) fenced pond areas is not at an acceptable level. The District will allow for a one-time cleanup charge for these areas. Attached is a revised price sheet for a one-time cleanup. The bed areas are not included in the one-time cleanup charge. The school will allow the bed areas to be brought up to bid specifications over a course of two month after the Board Approval of the bid. In the front parking lot there is a mound of pine bark mulch which can be used by the awarded vendor in the campus bed areas.

On page 27, Section 4.10, Paragraph f., Reads:

f. All Bermuda lawn areas will receive aerafication twice per year in November and April.

Page 27, Section 4.10, Paragraph f., Should Read:

f. All Bermuda lawn areas will receive aerafication twice per year in November and April once at 6" and the other at 10".

Page 27, Section 4.10, Paragraph h., remove from the bid specifications.
