## **ADDENDUM #1**

### **FURNITURE AND SHELVING FOR OSCEOLA HIGH SCHOOL**

#### **BID #SDOC 10-B-067 KB**

This addendum forms a part of the Proposal Documents described above. The original Proposal Documents remain in full force and effect except as modified by the following, which shall take precedence over any contrary provisions in the prior documents.

The following are questions I have received along with the laminate and fabric selections that you need to add to your copy of the price sheet:

QUESTION: On page 3 of the price sheet item 5.1, a Q05-3618 is specified that is 36 x 18 x 84. However, in the Tenssco catalog there is no such item number. In Tenssco, there is a Q05-3618S that is 36 x 18 x 87. Is this the requested item? These are from the Q-Line of Tenssco's line with bare shelves. Please advise.

ANSWER: What I need are prices for the Q05-3618S, which is the starter section and the Q05-3618A, which is the adder section. As of right now, I'm not sure how many of each I will need, so give me both prices and before I write up the order I will figure out the correct quantities. In the Tenssco Shelving Price List, effective April 1, 2009, on page 13 it has the upright post (OAP-84) in the 84"H that we have requested.

QUESTION: Item 3.9, the editing desk: Is a drawing of the alternate proposal acceptable?

ANSWER: I will accept a drawing, however if requested after the bid opening a picture must be provided.

In the description of the items in these groups it states "**Color Picture Required**". Please delete the word "**Color**", a picture is still required, but it doesn't matter if the picture is color or black and white.
