In addition, a Title I menu to access links to Title I is available through the school's website.

The curriculum being used at the school is addressed at the school SAC. At our Title I Annual Meeting, a PowerPoint is shared with the parents and families regarding the information on the standards the child is expected to achieve, what the child is learning, how the children are being evaluated, and how to get in touch with the teacher. We will provide families with instructions on how to sign up for the parent portal and school-wide REMIND. There will be a night about resources about parent portal, tutoring, technology, ESOL strategies, graduation requirements, academic resources based on Standards: Basic skills for Math, Science, ELA, Reading, Social Studies, Electives.
