Barriers

Transportation seems to be the biggest barrier. Childcare and Spanish translation are both provided for every SAC meeting.

Parent motivation is another area we would like to work on. In hopes of increasing parent attendance, LVES will be scheduling student performances/showcases or family event to follow each SAC meeting.

The school will work with community partners and Oasis volunteers to offer transportation to and from events and childcare during events. As a way to encourage parental involvement, the Principal has offered "Priority Pick Up Passes" for the first 15 parents to commit to serving on the School Advisory Committee (SAC). We will be working to incorporate Facebook Live or another form of streaming video of all SAC meetings so that business partners, teachers, or parents who are not able to attend can participate.
