Curriculum being used at the school is addressed at the school SAC and PAL's meetings. At our Title I Annual Meeting, a PowerPoint is shared with the parents and families regarding information on the standards the child is expected to achieve, what the child is learning, how the children are being evaluated, and how to get in touch with the teacher. Also, during back to school nights, parents will be able to see actual textbooks and materials that will be used in the classroom during instructional time.

Any parent is able to request a parent/teacher conference in person, telephone, or via Zoom. Parents may contact teachers via email or Class Dojo. All teacher email addresses are available on our school website or provided when calling the front office main number.

Class Dojo messages are provided in English and Spanish.
