Every new student that is enrolled throughout the year is provided a copy of the packet upon registration. In addition, a Title I menu to access links to Title I is available through the school's website.

The curriculum being used at the school is addressed at the school SAC and parent information meetings. During our Title I Annual Meeting, a PowerPoint is shared with the parents and families regarding information on the standards the child is expected to achieve, what the child is learning, how the children are being evaluated, and how to get in touch with the teachers.

Regular updates are sent to teachers and staff via emails to ensure all information is sent home with students on a regular basis. The school family engagement plan, "PFEP", will be summarized and a copy of the summary will be sent home to all parents. The PFEP will be posted on the school's website and its entirety.
