### **WELCOME TO OSCEOLA VIRTUAL SCHOOL (OVS)**

Osceola Virtual School requires a commitment from all school stakeholders. These stakeholders include the student, parent/guardian, director, professional school counselor, instructors and testing coordinator. OVS courses are delivered online and students are not required to attend a physical class in a brick and mortar school. Although there is not a physical classroom that students go to daily, students must meet all public school regulatory requirements set forth by School District of Osceola County and Virtual Instruction Programs. Listed below are the expectations/requirements for participation in Osceola Virtual School. Failure to comply with one or more of these as determined by the school director or designee is grounds for dismissal from the “Virtual School Option”.

### **Attendance & Pacing Expectations**

- Students should log on daily (M-F) into each course.
- Students who do not sign in for more than 10 days in a row may be referred to the Truancy Department
- Students should maintain a pace of 6% each week in each course
- Students will follow the School District of Osceola County’s school calendar

### **Testing**

- Students are required to complete any and all **national, state and district** required testing. Failure to attend the testing will result in immediate removal from the program.

## **Academic Integrity**

- Students who commit academic integrity may be dismissed from Osceola Virtual School
- Students are expected to complete their own schoolwork. It is unlawful to copy from the internet, have work completed by anyone else other than the student to whom the course is assigned.

## **Student Responsibility**

- Students must be on track within the first 14 day or risk being removed
- Students are responsible for scheduling the DBA'S (discussion based assessment) with teachers for each module
- Students are responsible for scheduling monthly calls with the teacher and parents
- Honors Courses – ALL Assignments should be completed to receive honors credit

## **Parent Responsibility**

- Attend mandatory parent meeting
- Review students' progress weekly
- Participate in monthly phone calls with teacher and student
- Maintain up to date demographic and contact information with OVS

## **Course Offerings**

- In the event that a course is not available through OVS, I understand that the equivalent course will be assigned to me through FLVS.

**I have read and understand this agreement with Osceola Virtual School and the rules and requirements set forth for students who attend this school. I am aware as a student and parent that failure to comply with any area will result in withdrawal of the student with no credit and/or risk further student disciplinary actions.**
