SPECIAL GUEST – *Superintendent Dr. Debra Pace*

- Penny Sales Tax (renewal/since 2004, currently expires 2024, renew for 20 more years)
- 1 cent to the dollar up to \$5,000
- Benefits Celebration: Track Field, Tennis Courts
- Building two new transportation departments in hopes to increase busing efficiency (bus inspections currently can only happen at Simpson Road)
- Separate from the half cent sales tax (2016)
- Operational Dollars/Capital Dollars (this funding cannot be used for operational funding- but can be used to cover security, technology (1:1 devices), construction- used to improve the buildings on current stations/athletic fields, etc.) Not Building New Schools
- Dr. Pace- Open Forum/Questions
 - Celebration Island Village (alleviate capacity) will open 2023
 - Impact Fees

- Christy Flanagan-Feddon motioned to approve minutes of the September meeting. Tanja Coronado-Odom seconded the motion. The motion carried unanimously.

SAFTEY REPORT – *Rhonda McMahon on behalf of Deputy Plaza*

- Dial Out Today (Threat Assessment) Unsubstantiated threat made today that was made as a joke. Law enforcement was contacted.
- Deputy Plaza was able to respond immediately.
- Threat Assessments- 1. Others, 2. Self (review of data from last year and current year)
- This information goes with students across schools within 3 days of transferring.
- Threat Cleared- No concerns.

- Dial out wasn't received by some parents. Rose will look at FOCUS dial out services to determine if numbers need to be updated.
- Visuals Around School (fortify Florida posters, "see something, say something" posters, etc.)
- No graphic illustrations such as guns are displayed around school.
- Halloween- Monday 31st- Extra Help for Trick or Treaters (Law Enforcement)
 - Plan for Traffic?
 - CDD is paying for 5 extra sheriffs.

PRINCIPAL'S REPORT – *Mrs. McMahon*

- Grading Standards (Literacy Coach Inputting Grades, Modeling Lessons for the Long-Term Sub)
- New LRS Coach. She will be working with K-3 teachers in ELA & Math and will serve as an interventionalist.

TREASURER'S REPORT – *Teia Hooper*

- Our current balances provided from our bookkeeper are \$21,375.15 in one account and \$194.85 in the other for a total of \$21,570. Our working balance is \$19,070.

FUNDS REQUESTS

- PE asked about attending conference & continuing electronic membership (1 year, provides ongoing learning/lesson plans). \$840 to send all PE teachers to go. Request for the funding to be reimbursed to school from SAC. (Professional Development- benefitting the entire school). Tabled to follow proper procedures. (Gamble to complete)
- Literacy/Math requests (will need to go through SAC)

OPEN FORUM

- Second Grade Class Split: first week in the classroom after split, all students seem to be adapting well, and teacher is being supported through other teacher
- Grading, Attendance, Moving from Co-Teaching, etc.- monitored frequently through MTSS, Tier 2/3 services,
- FOCUS interpretation: Teacher can go over codes and reports with parents. (FOCUS overview PARENT NIGHT- for newer parents)
- FAST reports- not available yet: school will send out once this is available
