**MOTION TO APPROVE NEW BYLAWS**

- Carl motioned to vote to amend the bylaws as outlined in the 5/17 e-mail (move elections from August to May), Debi Wisneski seconded the motion
- Christy Feddon proposed that the amendment is more clear in relation to the election of members vs council, Carl Fiore updated language
- Andrea Baker suggested that since we approved the bylaws in August we should follow them and possibly amend in the fall
- Nasser clarified that the only main change to the bylaws is the time when we vote, Carl Fiore confirmed that he was correct
- Liz Worley also stated that she questioned why the change needed to happen at the last minute
- Debi Wisneski clarified that the by-laws also state that if the sitting chair doesn't attend the fall meetings to chair the vote the school board would need to be brought in to end the current chair position prior to a new chair being elected.
- Mr. Weeden explained that he feels that May elections are a good idea but not at the risk of discord amongst the committee board
- Greg Filak (via phone) explained that since our practice was valid it makes sense to now match the bylaws to our precedented practice
