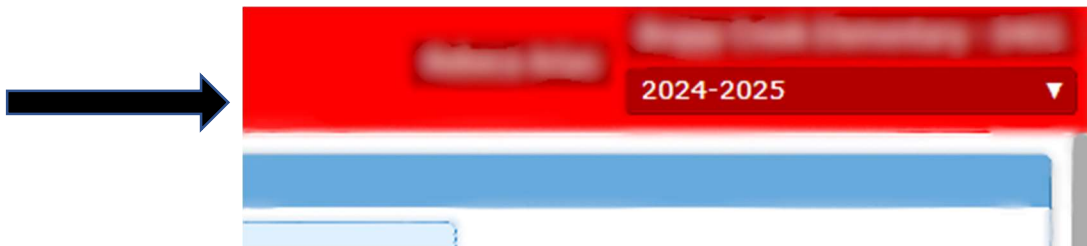


Formulario de Préstamo de Dispositivos Digitales para Estudiantes

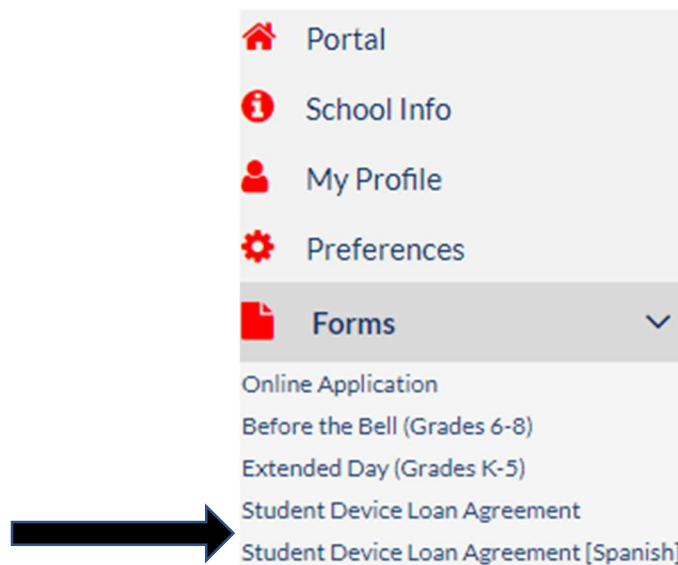
Paso 1.

Inicie sesión en el Portal para Padres de FOCUS. En la parte superior derecha de la pantalla, asegúrese de que se muestre la escuela correcta. Use el menú desplegable para cambiar la fecha del año escolar a 2024-2025.

Después de que se cargue la página, complete SOLO la siguiente información:

1. Seleccione el nombre del estudiante en el menú desplegable "Nombre del estudiante".
2. Seleccione la relación de padre a estudiante.
3. Seleccione Dispositivo y accesorios prestados. LA MAYORÍA de los estudiantes recibirán una computadora, un estuche y un adaptador/cargador de corriente.
4. Escriba el nombre y apellido del padre/tutor.
5. Firme digitalmente el documento donde dice el formulario: "Click to Sign".
