## POSITION DESCRIPTION

**TITLE:** Athletic Trainer/Teacher

**QUALIFICATIONS:**

1. Valid Florida Educators' Temporary or Professional Certificate.
2. Bachelor's or higher degree from a college or university professional athletic training degree program accredited by the Commission on Accreditation of Athletic Training Education.
3. Valid Certified Athletic Trainer card issued by the Board of Certification.
4. Valid Athletic Trainer License issued by the State of Florida.
5. Current certifications in First Aid, Cardiopulmonary Resuscitation, and Automated External Defibrillator.

**REPORTS TO:** Principal/Director

**POSITION GOAL:** This position will supervise the training of athletes involved in high school sports, student athletic trainers, and the athletic training room activities.

### PERFORMANCE RESPONSIBILITIES:

1. To provide basic instruction to athletic staff members regarding the prevention and care of injuries as the trainer's schedule and availability permits.
2. To teach no more than two classes per day related to athletic training.
3. To train and supervise student trainers for athletic contests and practices.
4. To refer injuries to physicians for diagnosis and/or treatments.
5. To carry out appropriate instructions and treatment as directed by the (athlete's) physician.
6. To develop and supervise appropriate rehabilitation programs for athletes under the direction of physicians.
7. To assist and advise the coaching staff regarding injury prevention, conditioning program and selection, and care and fitting of protective equipment.
8. To determine if an injured player is capable of continued participation in a game or practice.
9. To treat and/or supervise the treatment of all minor athletic injuries and conditions.
10. To organize inventory, and requisition all training room supplies.
11. To make and/or assist with arrangements for scheduling athletic physical exams for sports teams.
12. To provide training supervision and share facilities/staff with visitors at all major home meets, practices, tournaments, etc., involving a number of teams and a significant amount of time (Monday thru Saturday).
13. To attend all athletic events as the various sports calendars will permit with the extensions of trainer services provided by student trainers, when appropriate.
14. To report all injuries to the athletic office on the proper forms and keep an annual record of athletic injuries.
15. To avoid conflict of interest in availability, no coaching activities will be permitted while services as athletic trainer.
16. To plan and organize emergency procedures and injured athletes.
17. To communicate with parents regarding their student's injuries or conditions.
18. To act as the insurance contact person for all athletic injury claims (including filing of all necessary forms).

19. To maintain professional growth through membership and participation in the National Athletic Trainers Association and Athletic Trainers Association of Florida, clinics, and workshops on school time.
20. To have a flexible work schedule that permits the work day to cover most practice time schedules.
21. To have knowledge of technology as related to the emergency procedures, physical condition, and care of injuries.
22. To perform other duties as assigned by the Principal or designee.

**TERM OF EMPLOYMENT:** Ten (10) months – Teacher Salary Schedule

**EVALUATION:** Performance in this position will be evaluated by the Principal/Director in accordance with the Collective Bargaining Agreement.
